



TERMS AND CONDITIONS FOR THE MERCEDES-BENZ CORPORATE PROGRAMME

1. ELIGIBILITY:

- (a) The Mercedes-Benz Corporate Programme (the "Programme") is available to all full time employees (contractors are expressly excluded) of:
- (i) companies that are included in the top 500 companies by rank from the BRW Top 1000 list from time to time;
 - or
 - (ii) other companies that may be approved by Mercedes-Benz Australia/Pacific Pty Ltd ("MBAuP") from time to time. Your authorised participating Mercedes-Benz dealer will be able to confirm if the company that you work for is or has been approved. All applications for such companies to join the Programme are reviewed by MBAuP who will determine in its absolute and unfettered discretion if the company is approved for inclusion into the Programme.
- (b) To access the Benefits of the Programme (outlined in paragraph 3) you must:
- (i) purchase a new Mercedes-Benz passenger car from an authorised participating Mercedes-Benz dealer; or
 - (ii) purchase a dealership sales demonstrator Mercedes-Benz passenger car no older than 4 months and with no more than 4,000km on the odometer at the time of purchase; and (iii) register that vehicle in the name of the approved employee or approved company outlined in paragraph 1(a); and
 - (iv) apply for acceptance into the Programme at the time of the purchase of the vehicle. If you do not apply for acceptance into the Programme at the time of purchase you may not be eligible to access the Benefits of the Programme (outlined in paragraph 3); and
 - (v) provide evidence to your authorised participating Mercedes-Benz dealer of full time employment at an approved company (see paragraph 1(a)) at the time of application into the Programme.

All authorised participating Mercedes-Benz dealerships have a Mercedes-Benz Corporate Programme Consultant.

2. VALIDITY OF BENEFITS:

- (a) All Benefits of the Programme are only applicable to the original purchaser of the vehicle.
- (b) Benefits are not transferable.
- (c) Benefits are only valid for up to 3 years or 75,000 kilometres from the vehicle's first registration date (whichever occurs first) except for AMG vehicles for which the benefits are only available for up to 3 years or 60,000kms and all V12 powered vehicles for which the benefits are only available for up to 3 years or 50,000kms, except (in the case of all vehicles) for the 4th year of roadside assistance.

3. BENEFITS:

The Benefits of the Programme are as follows:

- (a) Most vehicles purchased under the Programme are preferentially priced ("Eligible Vehicles"). Contact your authorised participating Mercedes-Benz dealer for Eligible Vehicles and excluded vehicles. MBAuP reserves the right to change the Eligible Vehicles on which preferential pricing applies at any time and from time to time without notice to you.
- (b) Preferential pricing on all optional extras ordered with the Eligible Vehicle.
- (c) Reduced dealer delivery fee if the vehicle you purchase is an Eligible Vehicle.



(d) Free carpet floor mats if the vehicle you purchase does not come standard with carpet floor mats.

(e) Complimentary scheduled servicing for up to 3 years or 75,000 kilometres from the vehicle's first registration date (whichever occurs first) except for AMG vehicles for which the benefits are only available for up to 3 years or 60,000kms and all V12 powered vehicles for which the benefits are only available for up to 3 years or 50,000kms. Complimentary scheduled servicing must be conducted at an authorised participating Mercedes-Benz dealership. Only items covered by the scheduled servicing as detailed in the Mercedes-Benz Service Booklet are covered. All other items are excluded and are at your cost.

(f) During the period of complimentary scheduled servicing (detailed in paragraph 3(e) above) complimentary pick up and drop off of your vehicle may be provided up to 25 kilometres in each direction of the participating servicing Mercedes-Benz dealership subject to availability. Alternatively, a loan vehicle (the model type to be provided at the authorised participating Mercedes-Benz dealership's discretion) will be provided at no charge subject to availability. Customers should ensure they book in advance to improve their chances of access to a complimentary loan vehicle.

(g) 4 years total Road Care Service is included with each vehicle purchased under the Programme (that is, one year complimentary in the addition with the 3 years Road Care Service which is provided on all new Mercedes-Benz passenger car vehicle purchases). Refer to the Road Care Brochure terms and conditions for further information.

(h) Preferential finance rates and tailored financial services are made available by Mercedes-Benz Financial Services Australia Pty Ltd („MBFSAu“) subject to the usual credit approval process. MBFSAu recommends that applicants seek independent financial advice from an accountant and taxation adviser on their individual circumstances and that the appropriate terms and conditions are considered before any finance contract is entered into.

(i) Discount valet parking arranged by Mercedes-Benz Airport Express outlets in Melbourne and Sydney only. The discount rate is only available while the vehicle is covered by the complimentary servicing period in paragraph 3(e) above and is only applicable for the Mercedes-Benz passenger car purchased under the Programme. (j) Where a matching vehicle is not available at a participating authorised Mercedes-Benz dealership for the purpose of a test drive, the Mercedes-Benz dealership can contact MBAuP to request access to a suitable vehicle. Where a matching vehicle is available, MBAuP may, at its sole discretion, provide this vehicle for the purpose of a test drive.

4. OTHER:

(a) The dealers terms and conditions as agreed between you and the Mercedes-Benz dealership also apply to your vehicle purchase.

(b) MBAuP at its absolute discretion, may terminate the Programme at any time, for any reason and without notice. Existing members will continue to receive the Benefits under this Programme until those benefits expire.

(c) Mercedes-Benz Corporate Programme is available for Mercedes-Benz passenger cars only excluding SLS AMG and other vehicles from time to time at MBAuP discretion.
